## MEMBERSHIP DECLARATION



### 1. Declaration:

### 2. Other Rules:

# KIWI WEST AQUATICS

## Club Membership form



This is a membership form for swimmers/ parents who have registered with Kiwi West Aquatics for the first time

**1. Kiwi West membership Fee for full competitive swimmer- \$149 (First year competitive \$94).**

- The annual registration period is from 1 July to 30 June the following year. Swimmers may choose to register at any time of the year but will still be charged the full regional and national fees of \$91.50 (and a pro-rated club fee if not a first year competitive swimmer).
- Members who are registering with the club and Swimming New Zealand for the first time as full competitive swimmers will pay \$94 for the first year of registration and thereafter the full competitive fee.
- Payment for registration should be received before the club AGM for members to be eligible to vote.
- Swimmers will not be entered into any swimming meets until the registration payment has been received.

**2. Club Swimmer– \$55(Club Swimmer)**

- Club swimmers are also restricted to certain types of swim meets. Please contact the race secretary for suitable swim meets.

**3. Uniform**

- The team shirt and cap is compulsory for Kiwi West competitive members. The club also have a range of other uniform items from time to time members can purchase. Please contact a committee member to help you with organising a team shirt and cap

**4. Transferring**

- You will need to complete a transfer through the Swimming New Zealand Database.
- All applications from another club require an interview with the club coach, Interviews can be organised through the Nicholls Swim Academy located at the West End Pool. If accepted you will need to complete a transfer form and provide a copy of your swimming times (Preferably a Team Manager File, this should be available from your current swimming club)

**5. Parent/Caregiver Commitment.**

Your child’s success in competitive swimming will require a commitment from you as parent/caregivers. Kiwi West Aquatics rely on its members to support their swimmers and to actively participate in club activities.
